#### EXECUTIVE ORDER NO. 20, S., 2021

## MODIFIED GUIDELINES IMPLEMENTING THE EXTENDED GENERAL COMMUNITY QUARANTINE (GCQ) WITH HEIGHTENED RESTRICTIONS IN THE MUNICIPALITY OF BOLINAO, PANGASINAN

WHEREAS, Section 15, Article 11 of the 1987 Philippines Constitution mandates the right of every Filipino to health and Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 also provides that Local Government Units (LGUs) within their territorial jurisdiction shall protect and promote the health of the people and instill health consciousness among them.

WHEREAS, the Province of Pangasinan currently placed under General Community Quarantine (GCQ) with Heightened Restrictions has been extended until October 31, 2021 pursuant National IATF-EID Resolution No. 141-A series of 2021 dated September 30, 2021, thus there is a need to amend and or modified some provisions of the Municipal Executive Order No. 19, S, 2021 dated September 16, 2021;

WHEREAS, per legal opinion cited in a letter of Provincial Legal Officer, Atty. Geraldine Ubana-Baniqued dated September 22, 2021 harmonizing the Provincial EO 102-2021 with DOT Administrative Order No. 2021-004-A, it was cited that the National IATF-EID Guidelines and its amendments are automatically adopted and there is no need to re-estate them in toto but instead should be focused on local regulations that are given authority and discretion to implement by concerned LGU in their respective area of jurisdiction.

WHEREAS, the extended General Community Quarantine (GCQ) with Heightened Restrictions Up to October 31, 2021 necessitates the issuance of harmonized implementing guidelines consistent with latest Omnibus Guidelines of the National AITF-EID, Provincial Executive Order and other government agencies plus the recommendations of the Municipal IATF-EID;

NOW THEREFORE, I, ALFONSO F. CELESTE, M.D., Municipal Mayor of Bolinao, Pangasinan by virtue of the powers vested in me by law do hereby order the following modified guidelines to implement the extended GCQ with Heightened Restrictions in this Municipality.

#### SECTION 1 - TRAVEL RESTRICTIONS

- Non-APORS and tourists from areas under GCQ Alert Level 5, those under ECQ and MECQ and those under granular lockdown as declared by the DOH or their respective LGUs shall not be allowed entry;
- Non-APORS and tourists from MGCQ areas, GCQ areas, GCQ with Heightened Restrictions, and GCQ with Alert Level 1,2,3, or 4, regardless of age, subject to minimum health standards, shall be allowed entry, provided that:
  - They are fully vaccinated as evidenced by their Official Vaccination Card issued
    by their respective LGU as per applicable guidelines by the DOH. Full vaccination
    shall be construed to mean that the person/s concerned should have received their
    complete dosage of vaccine at least two (2) weeks prior to the scheduled travel to
    Bolinao;

- Travel shall be point-to-point. Point-to-point Travel refers to a direct and continuous travel from point of origin to the destination without stopping or changing routes through a transport hub ( DOT ADMINISTRATIVE ORDER NO. 2021-005-A);
- Tourists are discouraged not to visit the public market, groceries, trangges, and similar establishments where crowding with locals may not be prevented,
- For minors, they should be accompanied by their parents or guardians belonging to the same household
- Non-APORS and tourist without Certificate of Full Vaccination shall be required to present negative result of RT-PCR Test or Rapid Antigen Test.

## SECTION 2- COMPLIANCE TO HEALTH AND SAFETY PROTOCOLS

All existing health and safety protocols imposed by the government such as but not limited to mandatory wearing of face mask, regulated wearing of face shield and social distancing must be fully complied with. Non-compliance are punishable by existing laws and ordinances.

#### SECTION 3- LIFTING OF THE LIQUOR BAN

Effective October 1, 2021 the Liquor Ban imposed under Municipal Executive Order No. 19 dated September 16, 2021 is lifted. However drinking in public places is still prohibited. The sale and drinking of liquor and other intoxicating drinks shall be covered by existing laws and ordinances.

#### SECTION 4- DECLARATION OF CRITICAL ZONE

If there is a continuous increase or substantial spike in COVID 19 positive cases in a particular area, the LGU can declare the same as a critical zone in a barangay or sitio or residential block of a barangay where there is prevalent rise of Covid 19 cases to prevent spread of the virus. The recommendations of the concerned Punong Barangay shall be considered subject to the validation of the MHO and approval of the Municipal IATF-EID.

#### SECTION 5- CAMPAIGN FOR COVID 19- VACCINATION

To motivate and encourage all sectors who are still unvaccinated, the LGU launched a campaign dubbed as "BAKUNADONG PAMILYA," PROTEKTADO NA, MAY PAPREMYO PA" raffle tickets are available for free at the Office of the Mayor. Each individual who are fully vaccinated from October 1, 2021 until December 22, 2021 (12:00 Noon), is entitled for one ticket. Cash Prizes are stake and the raffle draw will be conducted on December 22, 2021 (3:00PM) through Face Book live Bolinao Tourism Page. Details of the mechanics of the raffle draw is stated at the back of the raffle ticket.

SECTION 6 - ALL OTHER CONSISTENT PROVISIONS OF MUNICIPAL EXECUTIVE ORDER NO 19, S., 2021 DATED SEPTEMBER 16, 2021 SHALL REMAIN IN FORCE AND EFFECT

- 3. Section 6 Oplan Sita
- Section 7- Reinstating Market Day Schedule
- 5. Section 8- Establishment Not Allowed To Operate

#### SECTION 7 - SEPARABILITY CLAUSE

Should any provisions of this order be declared by a court of competent authority as invalid or unconstitutional, the remaining provisions not adversely affected shall remain in full force and effect.
