EXECUTIVE ORDER NO. 11, S., 2021

AN ORDER PROVIDING REVISED GUIDELINES TO ADDRESS THE COMING OF ALL TOURISTS/VISITORS FROM NCR PLUS ALL OTHERS AREAS IN THE MUNICIPALITY OF BOLINAO, PANGASINAN

WHEREAS, Section 15, Article 11 of the 1987 Constitution states that the State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, Section 16 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 provides that every local government unit shall exercise its power to promote the health and safety of its people;

WHEREAS, pursuant to the recommendations of the Inter-Agency Task Force for the Management of Emerging Diseases (IATF) under Resolution No. 118-A dated May 31, 2021 endorsed to the Office of the President for approval the final risk-level classifications of Provinces, Highly Urbanized Cities (HUCCs) and Independent Component Cities (ICCs) effective June 1, 2021 up to June 30, 2021 as indicated in this IATF Resolution and that National Capital Region, Bulacan, Cavite, Laguna and Rizal (NCR Plus) shall remain under General Community Quarantine with the observance and implementation of restrictions until June 15, 2021;

WHEREAS, there is a need to adopt the guidelines and restrictions as embodied in the same Resolution with slight modification by the LGU to suit the emerging trend to allow tourism industry chance to recover without jeopardizing DOH and DOT health and safety protocols;

NOW THEREFORE, I ALFONSO F. CELESTE, M.D., Municipal Mayor of the Municipality of Bolinao, Pangasinan by virtue of the powers vested in me by law do hereby order providing revised measures and guidelines in the Municipality of Bolinao, Pangasinan during this period.

SECTION 1. Guests/Tourists/Visitors Online Registration

- All tourists/visitors coming to Bolinao are required to register at pangasinan.tarana.ph and apply for Travel QR CODE and register at s-pass.ph and apply for Travel Coordination Permit (TCP). Each traveler should have their respective QR code and TCP.
- All tourists/visitors for leisure coming from NCR plus, (National Capital Region, Bulacan, Cavite, Laguna and Rizal) are now allowed to travel in our area of jurisdiction starting June 3, 2021 to June 15, 2021 from point to point without age restrictions subject to negative result preferably RT-PCR and or Antigen Test requirement applicable to all ages not more than 72 hours prior to their travel and other protocols and restrictions imposed by the DOT and the LGU.

SECTION 2. Guidelines of Accommodation of Guests. Accommodation Establishments (AEs) accredited by the Department of Tourism (DOT) in areas

under General Community Quarantine (GCQ) and Modified GCQ (MGCQ) that are neither used as isolation Facilities nor Isolation Facilities may accommodate guests for leisure purposes, including those coming from the NCR Plus Area subject to the latest DOT advisory.

SECTION 3. Enforcement.

The LGU thru the Municipal Tourism Office with the assistance of Bolinao PNP shall be responsible in coordinating with all tourism facilities and Barangay Officials in the implementation of this guidelines.

SECTION 4- Repealing Clause

All inconsistent provisions of previous executive orders, memorandum and related issuances are hereby modified accordingly.

SECTION 3- Effectivity

This Executive Order shall take effect immediately and shall remain in full force and effect until revised or revoked.
